ORDER FOR OBTAINING IDENTIFYING EVIDENCE

Proof of affidavit having this day been made by Detective Warren Brewer #6828 a sworn Police Officer of the City of Phoenix, Arizona Police Department.

IT IS THE FINDING OF THIS COURT:

I

That there is probable cause to believe that the crime of Homicide has been committed, such offense being a felony punishable by more than one year in the state prison;

II

The procurement of a saliva sample by mouth swab from [redacted], white male, date of birth [redacted] may contribute to the identification of the individual who committed the offense;

III

That such evidence cannot be obtained by Detective Warren Brewer #6828 from either the Phoenix Police Department or the Criminal Identification Division of the Arizona Department of Public Safety;

IT IS HEREBY ORDERED:

I

That Detective Warren Brewer #6828, Detective Heather Polombo #6237, Detective Derrrell Branch #5986 or Detective Brian Hansen #6259 of the City of Phoenix Police Department is authorized to effectuate this order;

II

That a saliva sample by mouth swab from the person of [REDACTED] white male, date of birth [REDACTED] is to be obtained;

III

That this evidence is to be obtained for use in connection with the crime of Homicide;

IV

That this evidence is to be used to assist in the identification or exclusion of [REDACTED] white male, date of birth [REDACTED] as the perpetrator of the offense listed herein;

V

That the evidence shall be taken from said person at the facilities of the Phoenix Police Department or any other suitable location;

VI

That where applicable, evidence shall be taken in a medically approved fashion;

VII

That the evidence herein authorized to be obtained shall be taken as soon as reasonably practical following the issuance of this order, however, in no event may [REDACTED] white male, date of birth [REDACTED] be detained for more than (3) hours for the purpose of executing this order;

VIII

That said person shall accompany Detective Warren Brewer #6328, Detective Heather Polombo #6237, Detective Derrell Branch #6986 or Detective Brian Hansen #6250 with no interference or resistance, and shall cooperate by taking no action that would interfere with the effective taking of said evidence;

IX

That this order shall be valid until it is executed, but in any event not beyond fifteen (15) days from the date of issuance;

X

That this order is to be returned to this court not later than Thirty (30) days after the date of issuance.
