

A Big Team Win

y the time you read this, our contract, or memorandum of understanding (MOU), with the City of Phoenix for fiscal years 2021–2023, will have been presented to and passed by the City Council. I want to thank those of you who were able to take the time to come to the PLEA Office or attend virtual meetings explaining the proposed contract.

This contract not only provides for increased compensation, equipment stipends, trainer pay and more, but it is representative of community concerns, taking steps to address issues our City thinks are fair.

Our profession is changing. All it takes to see this is a quick glance at web news. Politicians are making new laws governing police practice, and municipal employers are modifying police policy. Read about some of the changes in our nation's largest police departments or federal proposals on universal police policy, and you will have a good idea of what seems to be inevitable. Change can be difficult, and particularly so when policy and practice have been the same for years, but it does not have to be bad.

Police reform is being seen everywhere, and the focus on Phoenix has intensified in the past three years, most likely because we are the largest city in the Southwest United States, and we have no formal office of oversight and are not under DOJ control. To us, the initial thought of changing any existing policy was absurd. "If it ain't broke, don't fix it." That argument was not enough for our elected officials, but more importantly, it was not enough for our community. Through polling, community meetings and input from our community partners, PLEA learned that most Phoenix residents support our Department, agree that we provide professional service, think we need more officers and want #9904 more transparency with the policies and

procedures that allow us to enforce laws in the City of Phoenix.

I think most of us understand that we work for our community and have no problem with the flexibility needed to be a government employee. We should have understood that when applying for the job of a police officer, public scrutiny is just a part of the package. Problems do arise when we are treated unfairly for doing what we are trained to do, being accused of an action we did not commit or following a policy that we did not make. There is a difference between making a mistake that can be corrected and committing a crime, and we know that our membership is unafraid of an honest look at honest actions.

The 2021–2023 MOU continues to provide the same due process rights that Unit 4 members are familiar with, and this is the most important part of the contract because it ensures procedures that account for fairness in discipline procedures, should you find yourself the subject of an investigation for a policy violation.

PLEA has built a reputation advocating for Phoenix police officers. We have turned those efforts to educating our community partners on the realities of being a police officer and the effects of policy on us and our families, and we are having great success. The positive relationship we have with our community as a police association will only serve to help us obtain fair policy for the future generations of Phoenix police officers. PLEA

hile COVID-19 has understandably been at the center of the dialogue concerning officer health and wellness throughout the past year, it's important to remember the devastating effects cancer continues to have on law enforcement officers around the country. All you need to do is visit vincerecancer.com/ screening to fill out a short form. Within one business day, you'll be contacted about setting up an appointment. (Please note, this is



currently not available to our retired members due to agreements between Vincere Cancer Center and the City of Phoenix.)

Of course, if a more comprehensive screening is needed afterward or you are referred out to a specialist, normal co-pays would apply. Your health is their absolute top priority, and these are some of the best medical professionals in the state.

This incredible program is a huge benefit to the men and women of the Department, so please don't hesitate to get in touch with the Vincere Cancer Center today at (480) 306-5390 or by visiting **vincerecancer.com**. The center is located in Scottsdale at 7469 E. Monte Cristo Ave.

Even if you feel perfectly healthy and believe a cancer diagnosis could never happen to you, do your loved ones a favor by taking this opportunity to schedule a free appointment. With most any medical issue, the earlier it is detected, the better the chance of beating it. 






FALLEN OFFICER MEMORIAL GOLF CLASSIC

PLEA Charities is a 501(c)(3) nonprofit organization that strives





Who Speaks for You When You Can't **Speak for Yourself?**

hether you're involved in a serious accident, are a victim of an unexpected life-threatening injury or are a patient undergoing routine medical care, it's important to have someone you trust available to speak for you in the event that you are unable to speak for yourself. We often think that planning only means making sure we have a traditional will, but it should mean a lot more than that.

• A medical power of attorney allows you to select individuals who can make healthcare decisions for you if you are unable to do so. This critical estate planning document lets you choose someone you trust to oversee your physical and mental health and to become the guardianship representative of

- all your medical affairs. However, it's not the only document
- A *living will* not to be confused with the document that dictates who gets your money or walks away with your prized possessions — allows and authorizes those you choose to remove life support if you become terminally ill or injured. It does not authorize a chosen individual to oversee any other medical directives — that's why you need both a living will and a medical power of attorney. Together, these documents properly address these situations by speaking for you when you can't speak for yourself.

Serious medical matters need to be addressed with legal documents that, in moments that could mean life or death, empower those you love and trust to make sure your wishes are honored.

If you have a will, at least you've made some decisions concerning who will speak for you (an executor) and who will be receiving your money (a beneficiary). However, a will does not protect #10812 you while you're alive. It's not designed to do that, and that's one of the serious problems associated with a traditional will. If you become incapacitated, a will alone cannot help because it does not name who you might want as your guardian.

"We believe every officer and all support staff within the PLEA family should seriously consider moving forward with a comprehensive estate plan to protect themselves and those they love," says Michael Napier, founder of the Napier Law Group. PLEA

If You Have a Grievance

First: Attempt to resolve the matter informally with your supervisor.

Second: If you cannot resolve this with your supervisor, contact one of the representatives above.

Remember: There are time limits to initiate a written grievance.

If You Are Being Investigated

Record: All interviews once you have been given an NOI.

Copy: All memos or paperwork related to the investigation.

Truthfully: Answer all questions related to the investigation.

If you are called by the Professional Standards Bureau (PSB) or any police supervisor regarding an investigatory interview or interrogation, you may have PLEA representation during that interview. Call for representation as soon as possible.

If you are contacted by the Special Investigations Detail (SID), do not speak with them until you have

contacted a PLEA Board member for referral to a criminal attorney. For your convenience, a PLEA Board member and representative are available 24/7.

During normal business hours, please contact the PLEA Office at (602) 246-7869. During weekends. holidays and after hours, contact the Radio Supervisor.


